This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered to compete.

Condition of the Dog. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the Fetch test. <u>Dogs with bandages, sutures, or visible wounds are not eligible.</u> Deaf dogs are allowed to enter so long as the handler is always in control of the dog, the dog can complete the requirements of the test, and the dog does not appear to be under undue stress in the opinion of the judge.

Bitches in season MUST wear properly fitted diaper to be tested as the last dog(s) at the end of the day. Please advise trial secretary ASAP if your bitch comes into season so we can move you to the end of the trial. Mwhaines56@gmail.com

In such a case, no refund of any fees paid will be made. The American Kennel Club and its agents, employees, and event personnel including judges, and helpers etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. Collars, Leashes and Harnesses. Dogs may wear slip collars, buckle collars and martingales in the AKC fetch test. They may NOT wear prong collars, e-collars, head collars, muzzles or body harnesses. LEASHES - should be 4ft to 6ft long and made of fabric, leather or biothane. Retractable leashes may not be used when on trial grounds.

Dogs must enter and exit the test area with the leash attached to the collar or harness, and under control.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

Bitches in season are allowed to "Fetch" at the end of the trial(s) and should not be waiting in the area with other dogs. A properly fitted diaper is mandatory to enter the Fetch area.

Judges are not required to wait for dogs: Dogs may be excused from the Fetch test or test area by a judge for excessive delay during the test, being found unfit to compete, interference with the test in progress by the owner or handler, or not being present when called to be tested. Dogs will be given 5 minutes grace time to arrive at the test area when called, if not the entry is forfeited. When a dog is excused during an AKC Fetch test, the excusal must be recorded on the Test Summary Form. The Owner of each dog is solely responsible for having it ready at the Fetch area when it is to be judged nor refunds will be issued.

Any Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations."
